

# Campus Safety and Security Report 2023

In 1990, Congress enacted the Crime Awareness and Campus Security Act (Title II of Public Law 101-542), which amended the Higher Education Act of 1965 (HEA). HEA was amended in 1992, 1998 and 2000. The 1998 amendment renamed the law the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act in memory of a student who was slain in her dorm room in 1986. It is generally referred to as the Clery Act. On August 14, 2008, the Higher Education Opportunity Act or HEOA reauthorized and expanded the HEA of 1965 and the Clery Act (34 CFR 668.46), as amended in conjunction with the Violence Against Women Act signed into law by President Obama on March 7, 2013. In compliance with this legislation, Pima Medical Institute updates and publishes this report annually detailing its crime awareness policies and procedures. This report is available on the PMI website, through the Consumer Information page, and a paper copy is available upon request at each campus location.

### **INTRODUCTION**

The following information is provided as testament to Pima Medical Institute's commitment to supporting the safety and welfare of its students, faculty, staff and visitors. While crises can occur even in the best prepared facilities, it is our goal to implement, prepare and practice for these crises in an effort to minimize negative outcomes. Pima Medical Institute has designed a Crisis Management Plan to maximize safety and survival, preserve property, minimize danger, restore normal operations, and assure responsive communications with the community and responders.

### **Crime Statistics**

Crime statistics for each Pima Medical Institute campus will be collected and reported by the Campus Director. The data will be maintained, along with this document, and reported, as required. The institution will make a good-faith effort to collect statistics for all Clery Act crimes committed in applicable geographic locations from all law enforcement agencies with jurisdiction for this institution. These statistics are updated annually (see attachments at the end of this report for Pima Medical Institute crime statistics for the past three years, by campus, as compiled by Campus Directors from police reports in their respective jurisdiction); all students and employees will be notified of the data, and a printed copy of this information is available for review by all students, faculty, staff and visitors upon request.

### **Emergency Management Team Contact Information**

Pima Medical Institute's Emergency Management Team consists of local campus personnel and corporate leaders. The Campus Director will serve as the Emergency Management Team Leader during a campus emergency or in the event of an alleged crime and should be contacted immediately. In case of emergency, staff and faculty shall not hesitate to activate emergency response services by calling 911.

# EMERGENCY MANAGEMENT PLAN – Campus Policies Regarding Procedures and Reporting of Criminal Action and Other Emergencies Occurring on Campus

All students and employees are instructed, during their student/employee orientation, of the Emergency Management Plan, which includes reporting, emergency response, notification, evacuation, lockdown, and timely warning procedures.

Emergency notification and evacuation drills are conducted biannually and the school maintains documented details of these drills. Upon request, written documentation of the drills will be provided at the campus level. Please contact the campus front desk to obtain more information about specific campus annual emergency response and evacuation tests.

### Reporting

Students or employees witnessing or involved in any kind of criminal action or emergency on campus shall report this event to their instructor or supervisor.

If the instructor or supervisor is unavailable, the student or employee shall report actions to any responsible staff member. All reports shall be given to the Campus Director or alternate campus Emergency Management Leader, who will implement the Emergency Management Plan as necessary. Pima Medical Institute encourages accurate and prompt reporting of all crimes to campus personnel and/or local law enforcement.

### **Emergency Response**

Pima Medical Institute will, without delay, and taking into account the safety of the campus community, immediately notify the campus community of a significant emergency or dangerous situation involving an immediate threat to the health and/or safety of those on campus, unless the notification will, in the professional judgment of responsible authorities, compromise efforts to assist a victim or to contain, respond to, or otherwise mitigate the emergency.

The Emergency Management Leader should be immediately informed of a significant emergency or dangerous situation; personnel should not delay contacting the local emergency response system should the Emergency Management Leader be inaccessible.

### **Notification Procedure**

- In case of emergency, 911 shall be contacted immediately.
- The employee who first learns of the significant emergency shall contact the Campus Director or alternate campus Emergency Management Leader on duty.
- The Emergency Management Leader will be responsible for implementing the Emergency Management Plan.
- The Emergency Management Leader will, upon confirmation that there is a significant emergency or dangerous situation involving an immediate threat to the health and safety of students or employees occurring on the campus, immediately notify the campus community.
- Initiation and content of the notification are the responsibility of the Emergency Management Leader.
- Notification will occur by means of audible alert, email, text messages, telephone calls or any other form of effective communication determined to best address the situation.
- If indicated, the Evacuation Plan will be implemented.
- The building will be secured and students and employees will be directed to a safe location.
- If indicated, a campus lockdown and shelter in place procedure will be implemented.
- The entire campus community will be notified of the emergency.
- The Chief Executive Officer or their designee will serve as the public information officer and be responsible for disseminating emergency information to the larger community.

Pima Medical Institute is utilizing the Omnilert notification system, which enables the Emergency Management Team Leader to initiate immediate notifications to all staff, faculty and students from their cell phone or computer. The system is tied to all student records in our database, which provides the added benefit of automatic updates to all contact information (cell phone numbers, landline numbers and emails) in real time, as students update their records.

### **Evacuation Plan**

All students are informed of the emergency evacuation and notification process during their new student orientation and as a follow up to evacuation drills. Employees are oriented to evacuation responsibilities during their new employee orientation and as part of a yearly Emergency Management Plan review. Evacuation routes are posted on each campus and information regarding evacuation and shelter-in-place locations.

### **Lockdown Procedures**

The Emergency Management Plan contains a campus lockdown procedure. In the event where the Emergency Management Leader deems it necessary to put the building into lockdown, the campus will activate the campus lockdown procedure. Testing of this emergency response procedure will be conducted and recorded no less than on a biannual basis.

### **Timely Warning**

In the event that a situation arises, either on or off campus, that, in the judgment of the President/CEO, the Corporate Director of Education, Director of Regulatory Operations, Campus Director or Emergency Management Leader, constitutes a serious, ongoing or continuing threat, a campus wide "timely warning" will be issued. A timely warning will be issued for any reported Clery Act crimes. The content of the warning will be determined by the Campus Director or Emergency Management Leader and will include at minimum all information that would promote safety and aid in the prevention of similar crimes. The warning will be issued in a timely manner through the college email, text messaging system and/or campus bulletin board posting to students and employees.

Anyone with information warranting a timely warning should report the circumstances to the Campus Director by phone or in person.

Testing of this emergency response procedure will be conducted and recorded at least on a biannual basis.

### **CRIME AWARENESS AND AVOIDANCE**

### **Policies Concerning Security and Access to Campus Facilities**

An orientation is held with new students and employees to inform them about campus security procedures and practices and to encourage them to be responsible for their own security and the security of others. Instructors and supervisors will continue to remind students and employees of their need to remain security conscious throughout their enrollment or employment.

All normal staff and employees are to display a Pima Medical Institute ID while on campus. Any visitors to the campus must obtain a visitor badge upon arrival.

Pima Medical Institute's program to inform students and employees about crime prevention is a one- on-one instructor to student, supervisor to employee communication of the need to be security conscious.

Identity theft is one of the fastest growing crimes in the nation and students may be particularly vulnerable to this crime. Learn how to protect yourself and your future from identity theft by going to <a href="https://www.ed.gov/misused.">www.ed.gov/misused.</a>

The campus area is accessible during normal business hours. Responsible management personnel will be available during all normal business hours to ensure timely response to any and all incidents reported.

Pima Medical Institute does not own or control any housing. Students and employees are advised to inquire with apartment managers and/or local law enforcement agencies as to residence security.

Maintenance of campus facilities is considered to be of the highest priority. All campus facilities will be maintained in an effort to ensure the highest standards of safety and security.

### **Policies Concerning Campus Law Enforcement**

Pima Medical Institute campus law enforcement is conducted by local law enforcement agencies. No written memorandum of understanding exists between Pima Medical Institute and the local law enforcement agencies. Pima Medical Institute will defer to local law enforcement agencies for investigation of alleged criminal offenses.

Student or employees who witness or are involved in any kind of criminal action or emergency and do not report the crime or emergency promptly may be subject to termination from enrollment or employment.

Pima Medical Institute has no recognized off-campus student organizations.

### STUDENT AND EMPLOYEE CONDUCT

Students or employees who violate PMI policies or regulations, harass or otherwise interfere with the progress of other students, may be terminated. Furthermore, students or employees who are under the influence of drugs or alcohol, cheat, steal, plagiarize or engage in any form of dishonesty, upon proof, are subject to immediate termination from enrollment or employment.

It is the practice of PMI to ensure that employees and students enjoy a learning environment that is based upon mutual respect, trust, and dignity. PMI is committed to providing a learning environment that is free of harassment. Harassment of any kind will not be tolerated and includes:

- Actions, words, jokes, or comments based on an individual's gender, race, ethnicity, age, religion, disability, or any other protected status;
- Actions intended to intimidate or cause fear; and
- Any form of unwelcome behavior of a sexual nature, including verbal, nonverbal, written, and physical actions.

An individual who has reason to believe that he or she is the victim of sexual or another form of harassment, or if any staff or students have witnessed harassment, should immediately report the incident to the Campus or Associate Campus Director in written form. An investigation will be initiated no later than five (5) working days and corrective action taken, if warranted. No action will be taken against those reporting harassment, regardless of the investigation's outcome. Those found to be engaging in any form of harassment will be subject to termination.

### **DRUG AND ALCOHOL POLICY**

The Drug-Free Schools and Communities Act of 1989 requires institutions receiving federal funds or financial assistance to establish and enforce a program to prevent the unlawful possession, use, or distribution of illicit drugs, prescription medications, and alcohol by students, and employees. The program includes a description of the health risks associated with the use of illicit drugs and alcohol, standards of conduct, sanctions under federal, state, local law, and campus policy, information on preventing drug and alcohol abuse, and available counseling and treatment options.

### **Health Risks**

Information about drugs of abuse uses and effects is available through the U.S. Drug Enforcement Administration and may be viewed <u>HERE</u>:

The use of illicit drugs and alcohol erodes the capacity to perform, think, and act responsibly. Long-term drug abuse can have a profound effect on a person's health and well-being. Any form of such substance abuse is considered to create an extreme danger in the school to both students and others and it can be grounds for termination of enrollment or employment at this institution.

All students and employees are hereby notified that the unlawful possession, use, or distribution of drugs and alcohol is prohibited on this institution's premises and during school-related tasks or functions. These "premises" are defined as all school property including building interiors and exteriors, common areas, sidewalks, parking lots, privately owned vehicles parked in the school parking lot, as well as desks, cabinets and storage areas. This prohibition applies to students and PMI employees performing any school related task, clinical externship, or attending any school sponsored function including field trips regardless of location on or off school premises.

### Sanctions

PMI will impose sanctions on students and employees for violations of the drug and alcohol standards of conduct consistent with federal, state, local law, and campus policy. Consistent with the severity of the violation, sanctions may include:

- Reprimand and warning.
- Substance abuse counseling, treatment, or rehabilitation program.
- Immediate termination of enrollment or employment.
- Referral to local law enforcement agencies for prosecution.

Local, state, and federal laws provide for a variety of legal sanctions and penalties for the unlawful possession, use, or distribution of illicit drugs and alcohol. PMI enforces a "zero tolerance" policy regarding underage drinking and will enforce state underage drinking laws on its campus premises. (Note: The minimum legal drinking age in the United States is 21, with the exception that in Puerto Rico the minimum legal drinking age is 18.) The consumption and/or possession of any alcoholic beverage by any person under the age of 21 is prohibited.

### State and Local Drug Possession, Use or Distribution Laws

PMI operates campuses in eight different states. Information on each location's State and Local drug possession, use or distribution laws can be found on the Pima Medical Institute website by clicking <u>HERE</u>.

PMI operates in states that have adopted recreational and medical marijuana laws. PMI follows these laws but does remind students that these laws do not supersede federal law or, generally, permit students or employees to be at school or in the workplace, as the case may be, in an impaired state.

### **Counseling and Treatment**

PMI recognizes drug and alcohol dependency to be an illness and a major health problem. The institution also distinguishes drug abuse as a potential health, safety, and security problem. Students needing assistance in dealing with drug/alcohol dependency are encouraged to utilize the Student Assistance Program or make contact with campus student services who can provide confidential counseling referrals, assistance, or information.

Employees needing assistance in dealing with such problems are encouraged to utilize the Employee Assistance Program or other appropriate counseling services. Conscientious efforts to seek such help will not jeopardize employment.

### DRUG AND ALCOHOL ABUSE PREVENTION PROGRAM

Prevention and early intervention strategies can reduce the impact of substance abuse. PMI students and employees are provided information during orientation regarding the PMI drug and alcohol prevention program and are encouraged to seek assistance when needed. PMI will annually distribute in writing to each student and employee a description of the health risks associated with the use of illicit drugs and alcohol, standards of conduct, sanctions under federal, state, local law, and campus policy, information on preventing drug and alcohol abuse, and available counseling and treatment options.

### FIREARMS AND WEAPONS POLICY

Pima Medical Institute strictly prohibits the possession of firearms and weapons on all campuses. Other than police officers or military personnel on active duty, no person, including a licensee, may possess firearms anywhere on campus, whether in a building or on the grounds. This prohibition extends to school owned and school-controlled locations, including sites leased for educational purposes.

### **Firearm**

- Any device that shoots a bullet, pellet, tranquilizer, spear dart, paintball or other projectile, whether loaded or unloaded, including those powered by CO2.
- This includes, but is not limited to, guns, air guns, dart guns, pistols, revolvers, rifles, cannons, etc., and any ammunition for any such device.

### Weapon

- Any device that is designed to or traditionally used to inflict harm. This includes, but is not limited to:
  - o Firearms, slingshots, switchblades, daggers, blackjacks, brass knuckles, bows and arrows, hand grenades, hunting knives, nun-chucks, throwing stars, or any object that could be reasonably construed as a weapon.

Anyone possessing a firearm or weapon will be asked to remove it from the campus or school event immediately. If the firearm and/or weapon is not immediately removed from the campus or school event, law enforcement will be notified and the emergency management procedures will be activated.

An employee aware of a violation of this policy is required to immediately notify the Campus Director or his or her direct supervisor. Any student, faculty or staff member violating this policy will be severely sanctioned, up to and including expulsion or termination. Additionally, violations of the school's Firearms and Weapons Policy may result in criminal prosecution.

### **SEXUAL VIOLENCE**

Pima Medical Institute does not tolerate sexual misconduct, including but not limited to sexual assault, harassment, exploitation, intimidation, dating violence, domestic violence, or stalking. It is the practice at PMI to ensure that employees and students enjoy a learning environment that is based upon mutual respect, trust, and dignity. The administration of PMI fully supports all local, state, and federal laws governing sexual violence and harassment and will cooperate to the fullest extent possible. PMI, in a good faith effort to comply with amendments to the *Clery Act*, as mandated by Section 304 of the "Violence Against Women Reauthorization of 2013", is committed to ongoing development of prevention and awareness programs, policies and procedures.

### **Sexual Violence Prevention and Awareness Program**

PMI offers all employees and students an educational program promoting the awareness and prevention of dating violence, domestic violence, sexual assault and stalking. The program is intended to promote healthy behaviors that foster mutually respectful relationships and encourage safe bystander intervention. Additionally, the program informs students and employees of their rights and the process when reporting a crime.

To support students and employees by providing and promoting the awareness of sexual misconduct; and to identify reporting rights and responsibilities by complying with the Clery Act (20 U.S.C. §1092(f)) and the Violence Against Women Act (42 U.S.C. §13925 et seq.) Pima Medical Institute has implemented the following processes:

### Terminology

- "Accused Person" is any individual who may have committed sexual misconduct.
- "Code of Conduct" is the PMI Code of Conduct, as amended from time to time.
- "Consent" to sexual activity is informed, knowing and voluntary. Consent is active, not
  passive. Silence, in and of itself, cannot be interpreted as consent. Sexual activity with
  someone known, or who should be known, to be mentally or physically incapacitated by
  alcohol or other drug use, unconsciousness or blackout, or otherwise unable to give
  consent, is in violation of PMI policy.
- "Hearing Officer" is the Campus Director at the relevant campus, the PMI Chief Executive Officer, or a member of the PMI senior management team.
- "PMI Community" includes all students, faculty, and other employees.
- "Reporting Party" includes any member of the PMI Community who claims s/he has been the subject of Sexual Misconduct by another person, as well as anyone who reports Sexual Misconduct.
- "Sexual Misconduct" includes, but is not limited to, sexual assault, harassment, exploitation, intimidation, dating violence, domestic violence, or stalking. PMI intends its definition to be broadly construed. Further, the definition applies at all times to all campus and school-related activities, including the PMI online environment.
- "Stalking" is the unwanted pursuit of another person, from following a person to work
  or showing up at a person's home to making harassing phone calls or leaving written
  messages or other objects.

### Victim's Rights

PMI strongly encourages all individuals to report incidents of sexual misconduct directly to law enforcement. Preservation of evidence may assist in proving an alleged offense occurred or may be helpful in obtaining an order of protection and therefore time is of the essence. PMI will assist with notification if requested. Victims have the option to decline assistance from law enforcement and campus authorities. PMI will support the rights of victims and adhere to protective orders resulting from legal action.

PMI will make accommodations or provide protective measures upon victim request and if reasonably available whether or not the victim chooses to report the crime.

### Reporting

A Reporting Party may submit a report to PMI alleging sexual misconduct. If the Accused Person is a member of the PMI Community, the report goes to the Campus Director or, in the alternative, to PMI's Chief Executive Officer. Reporting may occur in person, by phone, by email, or by letter.

When a report is received, PMI will provide the Reporting Party with written notification that explains the process, student and employee rights and options, accommodations, and options under this Policy, together with information regarding the availability of support services within both the institution and community. At the request of the Reporting Party, PMI will notify local law enforcement officials. If the alleged sexual misconduct is reported to law enforcement PMI will defer to law enforcement and take no further action until law enforcement has completed its process.

PMI will make available to a Reporting Party a PMI employee with training in victim rights issues, preservation of evidence, and campus and community-based resources. PMI will take measures to protect the identity of the Reporting Party and other necessary parties, including omitting personally identifying information about the Reporting Party, and maintaining the confidentiality of any accommodations or protective measures provided to the Reporting Party, as long as maintaining such confidentiality will not interfere with PMI's ability to provide the accommodations or protective measures.

PMI will, upon request, disclose to the alleged victim of a crime of violence, or a non-forcible sex offense, the report on the results of any disciplinary proceeding conducted by such institution against a student who is the alleged perpetrator of such crime or offense. If the alleged victim is deceased as a result of such crime or offense, the next of kin of such victim shall be treated as the alleged victim for these purposes

Students seeking information about counseling, health, mental health, victim advocacy, legal assistance, and other services available for victims, both within PMI and in the community should contact campus student services. Reporting Parties who seek assistance to request changes to academic, living, and working situations or protective measures should contact campus student services. PMI will provide such assistance without regard for whether the Reporting Party chooses to report the event to PMI or local law enforcement.

### **Standard of Evidence**

The burden of proof in all cases is the preponderance of the evidence, whether it is more likely than not that the sex misconduct in any form, including but not limited to sexual assault, dating violence, domestic violence, and/or stalking occurred. If the evidence presented meets this standard, then the respondent must be found responsible.

### Discipline

PMI will employ a process that is prompt, fair, and impartial from the initial investigation to the result. Any hearing will be conducted by officials who, at a minimum, receive annual training on sexual violence issues and how to conduct an investigation and hearing process that protects victims and promotes accountability.

The Reporting Party and the Accused Person will have the same opportunities to have others present during any institutional disciplinary proceeding.

### **Pre-Hearing Process**

- Preliminary Review; Resolution. The Hearing Officer will conduct a preliminary review of the
  allegations. If the Hearing Officer can resolve the matter with the consent of the Reporting
  Party and the Accused Person, in a manner which is also satisfactory to PMI, the Hearing
  Officer shall dismiss the matter.
  - Such disposition shall be final and there shall be no subsequent proceedings. The resolution shall be documented in a writing signed by the Reporting Party, the Accused Person, and the Hearing Officer.
- Charging Letter. If the matter cannot be resolved by agreement, and if the Hearing Officer
  believes the allegations, if proven true, justify disciplinary action, the Hearing Officer shall
  prepare a Charging Letter. The Charging Letter must provide notice to the Accused Person
  of the allegations and the nature of the evidence, and shall include the name of the
  Reporting Party. The Charging Letter must also:
  - o Identify Code of Conduct violations, if any;
  - Provide the Accused Person with a date certain by which s/he must provide the Hearing Officer with a request for a hearing;
  - Provide the Accused Person with a date certain by which s/he must provide the Hearing
     Officer with a written response to the Charging Letter;
  - Notify the Accused Person that s/he may be subject to discipline, which may include termination;
  - O Notify the Accused Person that, if a hearing is requested:
    - s/he will be required to provide the Hearing Officer with a copy of all documents, other evidence, and the name and addresses of the witnesses s/he she wishes to present at the hearing not less than five (5) business days before the hearing;
    - s/he will be entitled to receive copy of all documents, other
      evidence, and the name and addresses of the witnesses PMI will
      present at the hearing no less than five (5) calendar days before the
      hearing;
    - failure to provide such information may result in evidence or witness testimony not being considered;
    - information to be used at the hearing will be provided to the Reporting Party;
  - Notify the Accused Person that the deadlines may be extended for good cause with written notice to the Reporting Party and the Accused Person.
  - Notify the Accused Person that s/he and the Reporting Party will have the same opportunity to have others present during any disciplinary hearing, including the opportunity to be accompanied to any related meeting or hearing by advisor(s).
- **Investigation.** The Hearing Officer or his/her designee may conduct any appropriate investigation prior to the hearing.
- Interim Suspension. An Accused Person may be suspended from PMI on an interim basis if s/he is a student. An Accused Person who is a PMI employee may be subject to interim discipline. Any interim action shall be described in a writing, which shall also include all terms and conditions associated with the interim action.
- **Hearing Notice**. The Hearing Officer will send the Accused Person and the Reporting Party a Notice of Hearing, which includes the date, time, and location of the hearing.

- **Process**. Decisions about process shall be vested in the Hearing Officer. Information about the process shall be included with the Notice of Hearing.
- **Decision**. The Hearing Officer will issue his/her decision promptly after the hearing, in writing to both the Accused Person and the Reporting Party. The decision will state the judgment of the Hearing Officer, list any sanctions to be imposed, and state that the decision is final and binding on the Accused Person and the Reporting Party. The Hearing Officer may:
  - dismiss the case for insufficient evidence;
  - o find that no violation of the Code of Conduct occurred; or
  - o find that a violation did occur.
- Sanctions. PMI will support the rights of victims for orders of protection. Aside from any criminal penalties that may be imposed for sex offenses, the campus may take action; and, based upon its own investigation of the alleged offense, PMI may take the following actions.

  More than one sanction may be imposed, and sanctions may be modified by the Hearing Officer.
  - Warning. A notice in writing to the student that the student is violating or has violated institutional regulations;
  - Probation. A written reprimand for violation of specified regulations which places the student in a probationary status for a designated period of time and includes the probability of more severe disciplinary sanctions if the student is found to violate any institutional regulation(s) during the probationary period;
  - Loss of Privileges. Denial of specified privileges for a designated period of time;
  - Discretionary Sanctions. Work assignments, essays, or other related discretionary assignments;
  - School Suspension. Separation of the Accused Person from PMI for a definite period of time, after which the Accused Person is eligible to return;
  - Expulsion/Employment Termination. Permanent separation of the Accused Person from PMI;
  - Revocation of Admission and/or Degree. Admission to or a degree awarded from PMI may be revoked for fraud, misrepresentation, or other violation of PMI standards in obtaining the degree, or for other serious violations committed by an Accused Person prior to graduation;
  - Withholding Degree. PMI may withhold awarding a degree otherwise earned until the completion of the process set forth in PMI's Student Code of Conduct, including the completion of all sanctions imposed, if any.

### Confidentiality

The Hearing Officer shall obtain the written consent of the Reporting Party to identify him/her to the Accused Person. If the Reporting Party requests confidentiality, the Hearing Officer will take all reasonable steps to investigate and respond to the allegation in a manner consistent with the request for confidentiality. If the Reporting Party will not permit the disclosure of his/her identity under any circumstances, PMI's ability to respond may be limited. However, the Hearing Officer must evaluate the Reporting Party's position within the context of PMI's need to provide a safe and nondiscriminatory environment for the PMI Community. Thus, the Hearing Officer may weigh the request for confidentiality against the following factors:

- the seriousness of the alleged offense;
- whether the Accused Person has been the subject of other accusations; and
- the Accused Person's right to receive information about the allegations if the information is maintained by PMI as an "education record" under the Family Educational Rights and Privacy Act (FERPA), 20 U.S.C.§1232g; 34 C.F.R. Part 99.

The Hearing Officer shall inform the Reporting Party if s/he cannot ensure confidentiality. Even if the Hearing Officer cannot take action against the Accused Person because the Reporting Party insists on confidentiality, the School should pursue other steps to limit the effects of the alleged offense and prevent its recurrence.

### **Personally Identifying Information**

PMI will ensure that the Reporting Party's personally identifying information will not be included in any publicly available recordkeeping, including Clery Act reporting and disclosures such as the Annual Security Report and the daily crime log.

Personally identifying information is defined in Section 40002(a) of the Violence Against Women Acts of 1994 as individually identifying information for or about an individual, including information likely to disclose the location of a victim of domestic violence, dating violence, sexual assault or stalking, regardless of whether the information in encoded, encrypted, hashed or otherwise protected.

### Victim's Services

PMI does not offer on-campus victim's services; however, all students are encouraged to visit the student services department to receive information on services available in the community. Some of those services include:

- Domestic Violence Resource Center
- Office for Victims of Crime
- Community Legal Services

### **Sex Offender Registration**

### THE FAMILY EDUCATION RIGHTS AND PRIVACY ACT INFORMATIONAL GUIDELINES

The Family Educational Rights and Privacy Act (FERPA) of 1974 protects the privacy of student education records. The Act defines an "eligible student" as a student who has reached 18 years of age or is attending an institution of postsecondary education. The Act defines "parent" to mean a parent of a student and includes a natural parent, a guardian, or an individual acting as a parent in the absence of a parent or a guardian. An educational agency or institution shall give full rights under the Act to either parent, unless the agency or institution has been provided with evidence that there is a court order, State statute, or legally binding document relating to such matters as divorce, separation, or custody that specifically revokes these rights. When a student becomes an eligible student (turns 18), the rights accorded to, and consent required of, parents transfer from the parents to the eligible student. Under FERPA, parents and eligible students have the following rights:

The right to inspect and review the student's education records within 45 days of Pima Medical Institute (PMI) receipt of a request for access. A parent or eligible student should submit to the Campus Director a written request identifying the record(s) the parent/eligible student wishes to inspect and review. The school official will make arrangements for access and notify the parent/eligible student of the time and place where the records may be inspected. If the parent/eligible student is logistically unable to inspect and review the records at that time, PMI will make other arrangements to ensure the parent/eligible student is able to inspect and review the requested records.

## The right to request the amendment of the student's education records that the parent/eligible student believes is inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA.

If a record is believed to be inaccurate, a parent/eligible student should submit a written statement to the Campus Director that clearly identifies the part of the record(s) in question and specify why it is believed to be inaccurate, misleading, or otherwise in violation of a student's privacy rights.

PMI will notify the parent/eligible student of the decision to amend or not amend the record within 30 days of receiving the parent's/eligible student's request for amendment. Should PMI decide not to amend the record as requested by the parent/eligible student, the parent/eligible student will be informed of their right to a hearing regarding the request for amendment and be provided with information regarding hearing procedures.

The right to provide written consent before Pima Medical Institute discloses personally identifiable information (PII) from the student's education records, except to the extent that FERPA authorizes disclosure without consent. Exceptions that permit disclosure without student consent include the following:

- school officials with legitimate educational interests (persons employed by PMI in administrative, supervisory, academic or research, support staff positions including law enforcement unit personnel and health staff);
- persons or companies PMI has contracted with (such as an attorney, auditor, or collection agent);
- students serving on an official committee, such as a disciplinary or grievance committee or assisting another school official in performing his or her tasks; and
- (upon request) officials of another school in which a student intends to enroll.

A school official typically has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibilities for PMI.

The right to file a complaint with the U.S. Department of Education concerning alleged failures by the Pima Medical Institute to comply with the requirements of FERPA. The name and address of the office that administers FERPA is:

### **Directory Information**

FERPA permits public disclosure of directory information without the parent's/eligible student's consent unless the parent/eligible student has requested that directory information be withheld. Directory information is information contained in a student's education record that would not generally be considered harmful or an invasion of privacy if disclosed. FERPA requires each institution to define its directory items. PMI defines the following as directory information:

- Student name
- PMI email address
- Photograph
- Campus
- Field of study
- Dates of attendance
- Grade level

- Enrollment status
- Degrees
- Honors & awards

PMI does not publish a student directory. A student's directory information may be released to an inquirer, unless the student specifically requests that directory information be withheld. FERPA does not require that directory information be released. Parents or eligible students may elect to withhold directory information by completing and signing the Request to Withhold Directory Information form, which places the student record in a confidentiality hold status.

This form is available in the student services office. A request to withhold directory information is in effect permanently, even if the student is no longer enrolled at PMI.

A request to withhold directory information results in the following:

- Student name and program information will be excluded from all printed public documents and other similar printed material, such as commencement programs;
- Enrollment and degree-awarded inquiries from third parties, including potential employers and insurance companies, will neither receive a confirmation of enrollment nor graduation; and
- No information will be released to any person(s) on the telephone or via email.

A student's request for withhold of directory information does not permit the student to be anonymous in the classroom (including an online classroom) nor to impede or be excluded from classroom communication. A student's request for withhold of directory information does not preclude the student from having a student identification (ID) number. The directory information withhold can be removed if the parent/eligible student submits a written request for removal.

### **Release of Nondirectory Information**

Students may provide consent to release nondirectory information (financial and academic records) to designated third parties by completing a FERPA Release Consent in the student portal or by contacting the student services office. The release remains in effect until the consent is revoked in writing and the revocation is delivered to PMI.

### **COPYRIGHT INFRINGEMENT & COMPUTER SHARING**

### **Unauthorized Sharing**

The Digital Millennium Copyright Act (DMCA) is a federal law that is designed to protect copyright holds from online theft, which is the unauthorized distribution of copyrighted material is the unlawful reproduction or distribution of others works. The act covers music, movies, text and anything that is copyrighted. These provisions are designed to reduce the illegal uploading and downloading or copyrighted works through peer-to-peer file sharing. Sample violations include:

- Forwarding, downloading and saving, or copying copyrighted material through any electronic or physical medium (e.g., email, text, thumb drive).
- Joining a file share network and downloading unauthorized copies of copyrighted material.

A list of legal alternative downloading options is available through the PMI website or through the Dean of Instruction.

### **PMI Computing Resources**

Computing resources include all computers, related equipment, software, data, and local area networks for which the school is responsible as well as networks throughout the world to which the school provides computer access.

The computing resources of Pima Medical Institute (PMI) are intended to be used for its programs of instruction and research and to conduct the legitimate business of the school. All users must have proper authorization for the use of the computing resources. Users are responsible for complying with all legal and ethical guidelines of PMI computing resources. Users have a responsibility to respect the privacy, copyrights, and intellectual property rights of others. Use must be in accordance with school policy and applicable state and federal laws.

### **Violations**

Violations include but are not limited to the following:

The use of computing resources to:

- harass, threaten, or cause harm to individuals,
- interfere with the activities of others, and/or
- download or post material that is offensive, illegal, proprietary, and/or in violation of copyright laws.

In instances of copyright infringement or prohibited file sharing, PMI will take disciplinary action if there is evidence of one or more violations, which may include termination from the program and/or employment. If a complaint is received, Information Technology Services will disable network access for the listed device and attempts to identify the owner to inform them about the complaint. If the owner believes the complaint to be inaccurate, they will be given the opportunity to contest the finding when they meet with student services or their department.

### **Sanctions**

Copyright infringement is the act of exercising, without permission or legal authority, one or more of the exclusive rights granted to the copyright owner under section 106 of the Copyright Act (Title 17 of the United States Code). These rights include the right to reproduce or distribute a copyrighted work. In the file-sharing context, downloading or uploading substantial parts of a copyrighted work, without authority or permission, constitutes an infringement. Penalties for copyright infringement include civil and criminal penalties. In general, anyone found liable for civil copyright infringement may be ordered to pay either actual damages or statutory damages affixed at not less than \$750 and not more than \$30,000 per work infringed. For willful infringement, a court may award up to \$150,000 per work infringed. A court can, in its discretion, also assess costs and attorneys' fees. For details, see Title 17, United States Code, Sections 504, 505. Willful copyright infringement can also result in criminal penalties, including imprisonment of up to five years and fines of up to \$250,000 per offense.

Students and faculty will receive an annual notice of this policy. The PMI Corporate Education Department, Regulatory Department, and Information Technology Department will periodically review this policy, the institution's plans for the unauthorized distribution of copyrighted material, and the legal alternatives for downloading. Students and faculty will then be notified of the results of the review.

### **CLERY ACT REPORTABLE CRIMES/DEFINITIONS**

The following information comes from the Department of Education's Handbook for Campus Safety and Security Reporting (2016); Uniform Crime Reporting Handbook; Sex Offenses definitions from the National Incident-Based Reporting System Edition of the Uniform Crime Reporting Program; and definitions of domestic violence, dating violence and stalking adapted from the amendments made to the Violence Against Women Re-Authorization Act of 2013.

### **Hierarchy Rule**

When counting multiple offenses, PMI uses the FBI's Uniform Crime Reporting (UCR) Hierarchy Rule. This rule requires counting only the most serious offense when more than one offense was committed during a single incident.

### **Unfounded Crimes**

Crimes that were "unfounded" are excluded from these statistics. Only sworn law enforcement can unfound a crime and unfounded crimes only include those that were investigated by law enforcement authorities and found to be false or baseless.

### **Criminal Offenses**

**Murder/Non-negligent Manslaughter**: the willful (non-negligent) killing of one human being by another. **Manslaughter by Negligence**: the killing of another person through gross negligence. **Sexual Assault (Sex Offenses):** Actual or attempted sexual contact with another person without that person's consent.

**Rape**: The penetration, no matter how slight, of the vagina or anus, with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim. This offense includes the rape of both males and females.

**Fondling**: The touching of the private body parts of another person for the purpose of sexual gratification, without the consent of the victim, includes instances where the victim is incapable of giving consent because of his or her age or because of his or her temporary or permanent mental incapacity.

**Incest**: Sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.

Statutory Rape: Sexual intercourse with a person who is under the statutory age of consent.

**Robbery**: the taking or attempting to take anything from value of the care, custody or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

**Aggravated Assault**: an unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.

**Burglary**: The unlawful entry of a structure to commit a felony or a theft.

Motor Vehicle Theft: The theft or attempted theft of a motor vehicle.

**Arson**: The willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

### Violence Against Women Act (VAWA) Offenses

**Dating Violence**: Violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim. The existence of such a relationship shall be determined based on the reporting party's statement and with consideration of the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship. For the purposes of this definition, dating violence includes, but is not limited to, sexual or physical abuse or the threat of such abuse. Dating violence does not include acts covered under the definition of domestic violence. Any incident meeting this definition is considered a crime for purposes of Clery Act reporting.

**Domestic Violence**: A felony or misdemeanor crime of violence committed by a current or former spouse or intimate partner of the victim; by a person with whom the victim shares a child in common; by a person who is cohabitating with, or has cohabitated with, the victim as a spouse or intimate partner; by a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred; by any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred.

**Stalking**: Engaging in a course of conduct directed at a specific person that would cause a reasonable person to fear for the person's safety or the safety of others; or suffer substantial emotional distress. For the purposes of this definition, *course of conduct* means two or more acts, including, but not limited to, acts in which the stalker directly, indirectly, or through third parties, by any action, method, device, or means, follows, monitors, observes, surveils, threatens, or communicates to or about a person, or interferes with a person's property. *Reasonable person* means a person under similar circumstances and with similar identities to the victim. *Substantial emotional distress* means significant mental suffering or anguish that may, but does not necessarily require medical or other professional treatment or counseling.

### Arrests and Referrals for Disciplinary Action

**Weapon Law Violations**: The violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, concealment, or use of firearms, cutting instruments, explosives, incendiary devices or other deadly weapons. This classification encompasses weapons offenses that are regulatory in nature.

**Drug Abuse Violations**: Violation of laws prohibiting the production, distribution and/or use of certain controlled substances and the equipment or devices utilized in their preparation and/or use. The unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation or importation of any controlled drug or narcotic substance. Arrests for violations of state and local laws, specifically those relating to the unlawful possession, sale, use, growing, manufacturing and making of narcotic drugs.

**Liquor Law Violations**: The violation of state or local laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession or use of alcoholic beverages, not including driving under the influence and drunkenness.

### **Hate Crimes**

A hate crime is not a separate, distinct crime, but is the commission of a criminal offense, which was motivated by the offender's bias. If the facts of the case indicate that the offender was motivated to commit the offense because of his or her bias against the victim's race, religion, ethnicity, national origin, gender, gender identity, sexual orientation, or disability, the crime is classified as a hate crime.

**Larceny-Theft**: The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. Constructive possession is the condition in which a person does not have physical custody or possession, but in a position to exercise dominion or control over a thing. **Destruction/Damage/Vandalism of Property**: To willfully or maliciously destroy, damage, deface, or otherwise injure real or personal property without the consent of the owner or the person having custody or

**Intimidation**: To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

**Simple Assault**: An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

### The Annual Campus Safety and Security Report Availability

The following communication will be sent annually, prior to October 1st, via school e-mail to all students and staff.

Pima Medical Institute's annual security report is now available. This report is required by federal law and contains policy statements and crime statistics for the school. The policy statements address the school's policies, procedures and programs concerning safety and security.
