Articulation Agreement Guide



Pima Medical Institute (PMI) is committed to maintaining articulation agreements with education institutions to ensure transferable academic credit for PMI students and graduates. PMI develops partnerships and articulation opportunities that increase students' and graduates' accessibility to advanced educational opportunities.

PMI has agreements with the following institutions: Central Methodist University (CMU), Chadron State College (CSC), Chamberlain University (CU), Concordia University-Wisconsin (CUW), Excelsior College (EC), Grand Canyon University (GCU), Huntington University (HU), Penn Foster College (PF), Post University, University of Missouri (UMCVM), University of Phoenix (UOP), and University of St. Augustine for Health Sciences (USAHS). These agreements allow PMI graduates to transfer specific credits and/or pursue undergraduate or graduate degree programs (online or onground).

PMI students and graduates are subject to the terms of the agreements that are in place at the time of their enrollment in the partnering institution. Additional information about the agreements is included on the following pages.

The curriculum has grown to offer programs and courses in 52 majors and endorsements and eight master's degree programs. The six bachelor's degree programs attracting the most students are business administration, education, psychology, biology-health sciences, rangeland management, and justice studies.

CSC allows transfer of credit for six PMI associate degree programs: Dental Hygiene, Occupational Therapy Assistant, Physical Therapist Assistant, Radiography, Respiratory Therapy, and Veterinary Technician. Graduates of these six PMI associate degree programs can transfer up to 66 credits from the earned PMI degree toward fulfillment of the 120 credits required for completion of CSC's Bachelor of Applied Science (BAS), Bachelor of Arts, or Bachelor of Science degree. CSC is accredited through the Higher Learning Commission.

<u>Chamberlain University</u> (CU) prepares health care professionals with the knowledge, skills, values, and beliefs required to succeed and to make a difference in today's complex health care environment. CU has a College of Nursing and a College of Health Professions, a growing network of campuses, and online offerings.

PMI Associate Degree Nursing graduates who pass the NCLEX and maintain current, active Registered Nurse licensure will be awarded up to 77 proficiency credits hours through the Chamberlain College of Nursing Articulation Plan (CCAP). Proficiency credits are a block of credits that encompass a diploma or associate degree in nursing and professional experience as an RN. Upon acceptance into the RN to BSN option, a PMI graduate will be awarded 77 proficiency credits for nursing experience before beginning the program, and still have the option of transferring in additional coursework.

CU is accredited through the <u>Higher Learning Commission</u>. The Bachelor of Science in Nursing (BSN) degree program (including the RN to BSN degree completion option), the Master of Science in Nursing (MSN) degree program (including the RN-BSN to MSN option, the FNP track and all specialty tracks), and the Doctor of Nursing Practice (DNP) degree program at Chamberlain University are accredited by the <u>Commission on Collegiate Nursing Education</u>.

<u>Concordia University- Wisconsin</u> (CUW) is a regionally accredited, faith centered institution that offers a variety of degrees including associate, undergraduate, graduate, and doctorate. CUW offers on-campus and online degree programs.

Credit from select associate and bachelor degrees awarded at PMI will transfer to CUW; however, additional general education credits may be needed to fulfill the program requirements. The CU BSRS program is targeted to PMI Occupational Therapy Assistant (OTA) Associate degree program graduates, with a priority pathway to the Master of Occupational Therapy (MOT) and Occupational Therapy Doctorate (OTDe) programs; the CU DPT program is targeted to the PMI Bachelor of Science in Physical Therapy Assistant (BSPTA) degree program. The entry-level and post-professional programs offered at CUW are also available to other PMI degree graduates with the required admission qualifications.

To be guaranteed admission into the BSRS Program, graduates must transfer from PMI with an associate degree with a minimum overall GPA of 3.0, a minimum grade of B in anatomy/physiology and statistics coursework and meet all prerequisite coursework requirements. To be guaranteed admission to the MOT/OTDe Program, students much achieve a minimum overall GPA of 3.0 in BSRS coursework. To have priority admission into the Bridge DPT Program, graduates must have a bachelor's degree from PMI and minimum overall GPA of 3.0, a minimum 3.0 GPA in foundational science coursework, and meet all prerequisite coursework requirements. If the number of eligible PMI candidates exceeds the number of available slots in the preferred pathway to the DPT Program, a student may be required to delay start of the program for one year. Concordia University is accredited through the <u>Higher Learning Commission</u>.

Graduates from PMI's PTA program will be eligible to transfer 15 of the 24 pre-requisite credits required to HU's OTA to OTD program.

Applicants to the HU programs are required to submit a formal application and meet all other stipulated HU and programmatic entrance requirements in effect at the time of their application. Applicants are subject to all other institutional and programmatic policies and procedures related to HU's graduate study. Huntington University is accredited through the Higher Learning Commission.
